Meeting Minutes

Thursday, January 20, 2022

Treasurers Report: Motion to approve December 2021 treasurers report: Karen Andris, first and Karen Ervin, second. Approved.

2022 Budget: President Ashley called for discussion on proposed 2022 budget. No discussion. Motion to approve 2022 proposed budget: Lynette Stover, first and Georgia Ogas, second. Approved.

Correspondence: Diana McKay read a card from Trish Shelton. She also read a card from Lucy Vasquez who was the winner of the 2021 Opportunity quilt.

VP/Programs:

February program will be a fashion show, tips and tools.

March program will be Sheri with a cute pattern, Noeleen with

the curve ruler and Jenny on how to use zippers. There will be a workshop the next day with Jenny on making a bag with a zipper. \$20 for the workshop.

April program will be a **quilt as you go** with Pat Roberson. Next day a workshop on quilt as you go with a fun project. \$20 for the workshop.

May we will have the spring clean sewing room sale as a fund raiser for the club.

Importance of Non-Profit: We have several programs that satisfy our non-profit status: Little Quilts, Cradle quilts and Local Heroes. There are three things that define non-profit: 1. Charity, 2. Education, and 3. Religion, Scientific and Literary.

Little Quilts: Terry Gomez reported on Little Quilts in Jody Mead's absence. The group meets 9:30 am every other Tuesday at the Hillside Church. Call Jody if you have any questions. Each quilt is approximately 40 inches by 50 inches. The project has recently acquired a new sewing machine and is hopeful to obtain two more so that they do not have to bring sewing machines on the work days. They need backing fabric. The group makes up kits that members can take home to make. Everyone is welcome to come and sew, tie, cut and help.

Cradle Quilts: Lynette reported on cradle quilts. (But, she first told us how she got her really, really black eyes!) She read a nice thank you letter from Healthy Start Family Resource Center in Lindsay and told us how the Police Department appreciated the 98 book bags they were given to distribute. She thanked Sandra Dauer for all the book bags and supplies that she made and donated to the project. The book bags and supplies were especially good to have for little boys. She will have kits available next month for the doll quilts for the dolls that we give out in December.

Local Heroes: Margaret reported that there will be block kits available next month. The local heroes' project is chaired by Sheri Cates who was out of town for this meeting.

UFO: (Unfinished objects) Next month there will forms available to list your unfinished projects and at the end of the year the person who completes the most of the unfinished projects will win a prize.

New Non-Cash Donation Reporting Requirements

Good day members.

This information is intended to address, and hopefully clear, any questions you may have regarding reporting Non-Cash Donations you give to the Club.

I realize I am a fairly new member in the Club, and have not yet communicated with each of you personally. Therefore, you may not yet feel comfortable talking directly to me. As your Treasurer, I work for the Club, and that means I work for each and every member, i.e., for you. I want to make sure all of you feel comfortable and informed about any of the Club's accounting matters. If you have any questions or concerns about the Club's money matters, or any government filing requirements, please let me know.

It is part of my job as Treasurer to prepare all forms, tax filings, and pay any fees due to the government, both Federal and California. I really want you to know I welcome your questions, concerns and suggestions. Please feel free to talk with me at our meetings, or call me. My home phone number is 542-2671, and I welcome your call anytime. Please leave a message if you get my answering machine.

Reporting Non-Cash Donations given to the Club has never been done before, because the government never asked to know about them. Well, that changed in 2020. I have attached a copy of the notice that the Attorney General of the State of California, Ron Bonta, posted in the California Department of Justice website, stating that effective February 1, 2020, as part of completing the annual Form RRF-1, we must include information about Non-Cash Donations. I was not aware of this until the beginning of 2021, and that is when I created our Non-Cash Donation Received form, copy attached. These forms are available from Jody

Mead, Lynette Stover and me. The good thing about this is that the second copy (yellow) should be kept by you, and it can be used for your own Income Tax filing, to support your deductions for these donations.

Please understand that I do not like forms any more than you do, and I personally don't like all the fees and requirements imposed by California, but I don't make the rules. However, as my job is Treasurer, I feel it is my duty to be 100% truthful, honest and obey all laws and requirements of the government in order to keep the Club's head high and above water at all times. Please know that if you need further information, I am here for you, and please understand this new requirement is not my

good idea. It is a government requirement. Thank you for your understanding and cooperation.

February is Black History Month

Black History Month is an annual observance originating in the United States, where it is also known as African-American History Month. It has received official recognition from governments in the United States and Canada, and more recently has been observed in Ireland, and the United Kingdom.

I received my weekly newsletter from the Smithsonian in which there was an article celebrating fabric/quilter artist, Bisa Butler, for Black History Month. I watched a video of her describing her art, how she got started, her inspirations, fabrics she uses and so forth. I thought I would just watch a little bit of the almost hour but I ended up watching the whole thing and then looked at her art in a virtual tour on exhibit at the Art Institute Chicago.



All of her quilts are portraits and most are lifesize. Some are 6 feet tall and 9 feet wide! She uses a long arm to do the stitching and incorporates a variety of fabric, leather etc.








Forms

Home / Charities / Forms

Updated Forms Now Available!

Effective February 1, 2020, updated forms for charity, raffle and professional fundraiser registrants are required. Significant changes to the forms include:

- Charity registrants must file new Form CT-TR-1 annually along with Form RRF-1 if the registrant is not required to file and does not file IRS Form 990 or 990-EZ because they do not meet the revenue requirements. Registrants who file IRS Form 990 or 990-EZ do not need to file Form CT-TR-1;
- Annual registration renewal Form RRF-1 now requires reporting additional information, including noncash donations;
- Initial registration Form CT-1 now requires additional information such as
 DBAs and prior enforcement actions; and
- Changes were also made to all professional fundraiser forms and the raffle forms (registration and reporting).
