**Show and Tell** Members displayed their quilts for the final time this year. There will be no Show and Tell at the December.





Quilters who shared their work at the meeting were Sandy Whaling (first row—green, pink and peach), Phyllis Taylor (first row—black, white, and jewel tones), Janice Poe (first row-pink and blue), Anne Beverage (second row—black, white, and red), and Becki Eaton (second row—yellows and blues). The pattern featured pieced butterflies. Each quilter selected fabrics in light, medium, and dark intensities, cut and pieced the block, and sewed borders according to clues given each month. As you can see, the results are impressive. A new mystery quilt will be started in 2017. The cost is \$5 to participate.


















# Club News


